

Caltex Eastern Cape “3 Billionth Litre” Facebook Competition

TERMS AND CONDITIONS:

I agree and understand that I shall be bound by and comply with the terms and conditions for entry into the Seven Bridges Trading 23 (Pty) Ltd 3 Billionth Litre Competition (“The Competition”) and that in the event that I fail to comply with the terms and conditions for entry for any reason that my entry shall not be eligible for any prize and I may be disqualified from the competition.

1. The competition runs from 14:01 on Tuesday 8th June 2021 to midnight on 27th June 2021.
2. To enter, a participant shall guess which Caltex site in the Eastern Cape or Kokstad will receive the three billionth litre to be distributed by Seven Bridges Trading 23 (Pty) Ltd since they started trading. Participants should post their answer on the Caltex EC Facebook page in the comments section under the competition post. Sites may be identified by their trading name or by their street address. If it is not possible to clearly, without ambiguity, identify which site is being referred to by the participant, the entry will be discarded. A full list of sites, including their names and addresses may be found by downloading the Fuel Stations App at <https://app.caltexec.co.za> or on our website at www.CaltexEC.co.za/find-a-caltex.
3. Participants may only submit one answer. Should more than one entry be received from the same entrant, the first received entry will be deemed to be the valid entry, and subsequent entries discarded.
4. The four prizes are offered, each comprising R500 (five hundred Rand) worth of fuel vouchers. All fuel vouchers are to be redeemed at a Caltex site of the winners’ choice in the Eastern Cape or Kokstad.
5. Seven Bridges Trading 23 (Pty) Ltd accepts no responsibility for any variation in the worth of the prize due to fuel price variation or any other reason. The prize, or any unused portion is not transferable or exchangeable and cannot be taken as cash.
6. The competition is open to everyone domiciled in the Eastern Cape and Kokstad, except employees of Astron Energy, Caltex, Seven Bridges Trading 23 (Pty) Ltd their advertising and promotional agencies, marketing service companies, other suppliers, their retailers and retailer employees and the immediate family members (parent, child or sibling) of all of the above.
7. To qualify for a prize, a participant may not have won a prize with a different competition from Seven Bridges Trading 23 (Pty) Ltd within the past 90 days.
8. For avoidance of any doubt, it is specifically stated that there is no obligation on the part of any participant to purchase fuel in order to enter this Competition.
9. Entries containing or depicting illegal, sexually explicit or morally or racially offensive content will not be eligible to win and will be deleted and the participant may be barred from the Caltex EC Facebook page, at the discretion of Seven Bridges Trading 23 (Pty) Ltd.
10. The potential winners will be selected using a random number programme. Every contestant that correctly guessed which service station received the 3 billionth litre will be entered into a draw and four potential winners will be selected using a random number programme.
11. Should there be no, or insufficient, correct entries, the surplus prize vouchers will be offered to a registered charity nominated by the service station that received the 3 billionth litre.

12. The decision of the judges at Seven Bridges Trading 23 (Pty) Ltd is final and no correspondence shall be entered into. Seven Bridges Trading 23 (Pty) Ltd may in its sole discretion decide that an entry is not eligible for the competition and may disqualify the entry even if the entry is correctly submitted.
13. The potential winner will be contacted via Facebook Messenger Inbox, or in a comment below the entry post, with a request for a contact phone number. The potential winner will have three days in which to respond, after which they will be deemed not to have accepted the prize, and a replacement potential winner will be selected using the same random number process.
14. A verification process will then be carried out via telephonic voice interview. Winners are required to adhere to the verification process in order to claim their prize. Should a potential winner be ineligible in terms of these terms and conditions, or should the winner be unwilling or unable to comply with the verification process, a replacement potential winner will be identified, and the process repeated.
15. Each prize may only be awarded to or taken by the person who is a winner of a prize. It is noted that the person that posted the winning post will be considered to be the winner if there is any dispute.
16. The prize may either be collected in person or the winners may have the prize couriered to them. If collected in person this will be at an Eastern Cape or Kokstad Caltex service station of their choice or alternatively at either the PE office or the East London office during office hours. If the winner requests that the prize is couriered, the winner exonerates Seven Bridges Trading 23 (Pty) Ltd and their chosen carrier from any liability in the event that the voucher does not arrive or is incorrectly delivered.

Seven Bridges Trading 23 (Pty) Ltd requires the winners to produce a copy of their ID or other identification, and to complete and submit an information disclosure agreement and indemnification to enable Seven Bridges Trading 23 (Pty) Ltd to ensure compliance with these rules and the Consumer Protection Act 68 of 2008. In the event that the winner requests a courier to deliver the prize, these documents must be scanned and returned to the designated email address prior to the prize being dispatched. Should any winner refuse or be unable to comply with this rule for any reason, such winner will be deemed to have rejected the prize and it shall revert back to Seven Bridges Trading 23 (Pty) Ltd.
18. It is noted that if the voucher is lost, once it has been signed for by the winner, Seven Bridges Trading 23 (Pty) Ltd will not be able to replace same.

Prize winners, on acceptance of prizes, may be requested to participate in publicity or broadcast or publishing with Seven Bridges Trading 23 (Pty) Ltd internal or external communication including social media. Names of the winners (first name, last initial and town of residence) may also be announced on the Caltex Eastern Cape Facebook page.
20. All entries and any copyright subsisting in the entries become and remain the property of Seven Bridges Trading 23 (Pty) Ltd.

Seven Bridges Trading 23 (Pty) Ltd collects contact information about entrants in order to contact them about the competition and where appropriate award prizes, and may also use the information to assist Seven Bridges Trading 23 (Pty) Ltd in improving goods and services and to contact entrants in the future with special offers via any medium including mail, Facebook inbox and commercial electronic messages.
22. Seven Bridges Trading 23 (Pty) Ltd is not responsible for any problems or technical malfunction of any telephone networks or lines, computer on-line systems, servers, or providers, computer equipment, software, technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to participants or any other person's computer related to or resulting from participation in or down-loading any materials in this competition.
23. Seven Bridges Trading 23 (Pty) Ltd will not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal

injury suffered or sustained in connection with the prize/s, except for any liability which cannot be excluded by law. Seven Bridges Trading 23 (Pty) Ltd will not be responsible for any incorrect, inaccurate or incomplete information communicated in the course of, or in connection with, this competition if the deficiency is occasioned by any cause outside the reasonable control of Seven Bridges Trading 23 (Pty) Ltd including without limitation technical malfunctions or failures or warranties (including warranties and functionalities of the prize/s).

24. Seven Bridges Trading 23 (Pty) Ltd shall have the right to terminate the competition immediately and without notice. In the event of such termination, all participants agree to waive any right that they have to recourse against Seven Bridges Trading 23 (Pty) Ltd their agents, service providers, publishers and or promoters.

Seven Bridges Trading 23 (Pty) Ltd also reserves the right in its sole discretion to disqualify any individual who Seven Bridges Trading 23 (Pty) Ltd has reason to believe has breached any of these conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the competition. Unfair practices such as, but not limited to, suspicion of vote rigging, creation or use of false profiles to gain an unfair advantage, shall fall within this clause. Determination of whether a practice is unfair rests with Seven Bridges Trading 23 (Pty) Ltd and no discussion of such a decision will be entertained. Seven Bridges Trading 23 (Pty) Ltd's legal rights to recover damages or other compensation from such an offender are reserved.
